Tuition fees include, inter alia;

1. **Checkpoint Primary Stage 2, 3, 4, 5 and 6:** English, Maths, Science (Chemistry, Physics and Biology, Afrikaans, French (using online material) Art, History, Global Perspectives, ITC. [Internal exams/assessments fees included in annual fees].
2. Includes internal Cambridge Primary learner assessment fees.
3. Includes access to Sagan Academy digital classrooms.

TERMS AND CONDITIONS

1. **Application fees:** A non-refundable **application fee** of R750 must accompany this registration for all applications.
2. **Registration fees**
Take note of options
 - a) **Registration fee full time JUNIOR students** –Stage 2,3, 4, 5 and 6: non-refundable fee of R5 870 is payable on new registrations only.
 - b) **Separate invoices** will be issued for the application and registration fees (one invoice); and for school fees (one invoice and customer statements).
 - c) **International /Foreign students:** (those that do not hold South African Citizenship) are required to pay
 - a) the application and registration fee, and
 - b) a full terms fees upfront on registration in advance. Each term thereafter is paid in full before a new term.
3. Monthly tuition fees are payable on the final working day of each month, **in advance**, by EFT, from 1 January, of a given year up to and including **12 months**, for **Sagan Junior**, thereafter, the final payment being 1 December of any given year.
4. **A full term’s notice (being three months), in writing, or the equivalent fee in lieu thereof is required prior to withdrawal of a learner.**
5. Tuition fees will be reviewed annually. A term’s notice will be given of any increase.
6. Where any account is more than 21 days in arrears the learner will be suspended from the Sagan Centre and the access to the premises refused until outstanding fees are paid.
7. Transfer cards will not be issued to school leavers in respect of whom monies due to the school are outstanding.
8. Sibling discount will be 7.5% on the eldest sibling’s fees for 2 children. 10% will be allowed on the total fees for all children 3 or more. This discount applies to tuition fees only. The educational levy is not included in the discount
